Sub: Enhancement of licence fee & special water rate w.e.f. 01.04.2021.

Sir,

In inviting reference to your Letter No. 7855 / WE dated 08.03.2021 on the subject noted above, I am directed to say that as per Amendment made in Rule-23-A (2) (I) of Odisha Irrigation Rules, 1961 vide Odisha Irrigation (Amendment) Rules, 2016, the licence fees / special water rate for drawal and use of water shall be enhanced @ 10% per annum w.e.f. 1st day of April.

Accordingly, the 5th annual enhancement @ 10% will be effective from 01.04.2021 to 31.03.2022. The enhanced rate chart of special water rate & licence fee are annexed vide Schedule-II & Schedule-III respectively.

It is, therefore, requested to circulate the above licence fees / special water rates among all Sub-Ordinate Officers under your administrative control for further follow up action.
