SUBJECT— Fixation of jurisdiction of divisions for collection of industrial water rate.

No. 27919—Irr.-II-WRC.-79/2008-WR.—Sustainability of operation and maintenance (O. & M.) of the water resources infrastructure in the State has become the prime concern of the Government for quite sometime in the past. Steps have been taken for rationalizing the O. & M. cost recovery from all the users. Industry being the economically stable users, collection of water rate from them plays a vital role in sustainability of O. & M. of water resources infrastructure. To streamline the control over drawal of water and collection of water rate from all the industries it has become imperative to fix the jurisdiction of the Executive Engineers of the divisions of Water Resources Department for the purpose.

After careful consideration Government in Water Resources Department have been pleased to fix the jurisdiction as below :—

2. This will come into force with immediate effect.

3. All new agreement with Industries on water use shall be made as per the above arrangement

4. Industries drawing water under the existing agreements, shall execute agreements with the concerned Executive Engineers as per this notification at the time of renewal or after expiry of the current spell of the existing agreement.

Term of Reference :

- (i) Division fixed with jurisdiction for the above purpose shall exercise their power as per the erstwhile Revenue and Excise Department Notification No. 51010, dated the 29th September 1999.
- (ii) Division fixed with jurisdiction for the purpose on geographical boundary will specify accountability for collection of Industrial Water Rate.
- (iii) Divisions fixed with jurisdiction for the purpose should take measures to include the left out and new user agencies for collection of Industrial Water Rate.

ORDER—Order that the Notification may be published in the *Orissa Gazette* and copies of the same forwarded to all Departments of Government/all Heads of Department/all Collectors of the State.
